President Frazer noted there is a quorum present.

Discussion, consideration and possible action pertaining to owning and raising chickens on private properties in the Village of Fox Point

Trustee Tirado introduced the topic and gave background on the agenda item.

Julie Parve, 500 E Fox Dale Court

Mrs. Parve of the Fox Point Backyard Chicken Organization, Nurse Practitioner, and Professor gave background on owning and raising chickens, as well as other municipalities that allow chickens. She noted the best and healthiest places to live permit backyard chickens in their communities.

Erica Waldau, 7218 N Longacre Road

Ms. Waldau reported she has been working with the group on research and she is in support of the chickens in the community if neighbors wish to have them.

Jeff Ziebelman, 8017 N Whitney Road

Mr. Ziebelman he noted his support for chickens and requested the village not spend a lot of money on regulations and ordinance research to own and raise chickens in the community.

Michael Day, 7629 N Bell Road

UWM Professor Day conveyed having chickens is normal in the country where he grew up and indicated his support, noting chickens pose no threat to anyone.

Kate Cooper, 707 N Juniper Lane

Ms. Cooper noted her support for chickens in the community regardless of whether she decides to raise them or not.

Elizabeth Aelion, 210 W Bergen Ct.

Ms. Aelion supports chickens in the community, commenting other pets are allowing including dogs which can be of more danger to citizens then the chickens. They are considered pets and they are healthy.

Dr. Mary Beth Alvarez, 7138 N Lake Drive

Dr. Alvarez confirmed her support of chickens; she raised chickens in New Orleans prior to living in Fox Point. She mentioned Other Ordinances ask for permission from the neighbors and she hopes the village doesn't do that.

Dr. Gisela Chelimsky, 7950 N Lake Drive

Dr. Gisela Chelimsky is also in support of chickens even if she does not have chickens.

North Shore Health Department Director Officer Ann Christiansen spoke in regard to health issues. Salmonella, Bird Flus, and nuisance complaints are all concerns with backyard chickens. Clear guidelines are necessary. Chickens can attract raccoons and coyotes to the area as well.

It was suggested that the expectation of what a clean coop should be would be outlined in an ordinance for consideration. Oral contamination or transfer from hands would spread Salmonella; it can be brought in on shoes as well. It was observed, people can also catch illnesses from many pets if hands are not washed.

Mrs. Parve addressed concerns and answered questions.

Lance Parve, 500 E Fox Dale Court

Mr. Parve is an engineer and resident and works for the city of Brookfield. He noted the aesthetics of the chicken coops are important and can enhance the community.

Trustee Christine Symchych commented she would prefer staff and legal input on this matter prior to going any further holding this over until the next meeting.

Kate Cooper, 707 E Juniper Lane

Ms. Cooper stated she has been a realtor for the last 15 years and stated she has never had an issue selling a home because of a chicken coop.

Mr. Ziebelman, 8017 N Whitney Road

Mr. Ziebelman noted this has been long and coming; the community should not have to revisit this again.

Village Manager Scott Botcher gave a brief synopsis of the procedures remaining prior to any ordinance or permission of chickens in the village. He noted the staff may have to look at potential impacts prior to moving forward. Mr. Botcher suggested a staff report.

Attorney Larson noted the ordinance issues that were considered in 2012. He noted a decision should be made on the type of policy to put in place.

Trustee Tirado suggested a public education meeting.

President Frazer echoed the thoughts of Trustee Symchych in asking for input from the staff. Trustee Fonstad noted procedurally, he would like to refer this to staff and bring back a report.

Manager Botcher suggested a policy brought back in July and an ordinance be brought back in August. President Frazer noted this will be postponed until August.

Village Board discussed and considered at length owning and raising chickens on private properties in the Village of Fox Point.

Report provided by Village Manager Scott Botcher on Comprehensive Plan Update Process

Village Manager Scott Botcher gave a brief background on the Comprehensive Plan Update Process. Mr. Botcher suggested that the matter be placed on the next regular village board meeting agenda.

Village President Frazer extended his condolences to the Village Manager Scott Botcher on his father's passing.

President Frazer commented on the successful of the open house held on Saturday, June 9, 2018. He thanked the staff who attended the open house. He also commended Trustee Symchych and Trustee Sumner for assisting with the Pool Committee's attendance.

President Frazer noted the up rooter tool has been used quite a bit and has a waiting list.

Trustee Symchych reported on the Audit Committee; Audit Committee met last week and the audit was accepted as final. Trustee Symchych commented the audit books (Financial Statements and Communication to those Charged with Governance and Management) have been distributed for review by the trustees. An audit presentation time is currently being coordinated by the Village Manager and the Village Auditor.

Trustee Tirado reported on the purely conceptual design of the Fox Point Community Pool by the CDS team. He reported a large display board and table with information was exhibited at the open house. Really good questions and feedback were received from stakeholders; this information continues to raise awareness on what the committee is working towards. He thanked the village for the third annual open house and the additional signage to assist with open house event knowledge.

Trustee Kravit reiterated the sentiments on the open house, stating the event went very well and it is good for the village.

Trustee Kravit observed the village is in very fine condition financially according to the audit. He commended Village Manager Scott Botcher for a job well done.

Trustee Ollman recapped the success of Saturday's Village of Fox Point open house.

Village Manager Scott Botcher noted the audit is available; it should be presented at the August village board meeting.

Manager Botcher reported on current staff changes. Deputy Clerk Jilline Dobratz accepted the Clerk/Treasurer position at the Village of Jackson. A City of Glendale six-year administrative assistant Tia Ritter has been hired to fill the vacant Administrative Position in Fox Point. She will begin full-time employment on June 20, 2018.

Village Manager Scott Botcher announced The Fresh Market did not meet the deadline for the liquor license publication and June Village Board approval. He commented a potential special village board meeting may be scheduled for Tuesday at 5:00 p.m.

Manager Botcher presented the new Fox Point Police Department pedestrian safety signs.
