ADMINISTRATION

2. Fox Point Board of Review met on Tuesday and set Open Book for August 8 from 5-7pm. The Board will reconvene September 6 at 5:30 pm.
3. Interviews were held w two candidates for the vacant Administrative Assistant position.
4. Staff attended the UWM MPA Alumni event in Shorewood.
5. Azura Memory Care hosted a neighborhood meeting at Village Hall on Thursday, May 24.
6. Pool Staff continues to prepare for the upcoming season.

DEPARTMENT OF PUBLIC WORKS

1. Interviews continue for the open Mechanic position.
2. The construction at Poplar and Club Circle is ongoing.
3. Staff tended to a water main break on Goodrich Ct.
4. Staff replaced water valve and hydrant at Willow Ct. and Indian Creek.
5. Tree planting continues.
6. Staff met with MMSD to discuss Indian Creek.
7. Staff responded to a questionnaire regarding a 2019 RFP project.
8. Staff completed DNR sanitary sewer report.

POLICE DEPARTMENT

1. On May 17, 2018 at 4:28pm, an officer conducted a DOT inquiry for a vehicle license plate and the response showed the vehicle was stolen. With the assistance of another officer, the vehicle was stopped using a high-risk traffic stop in the 8700 block of North Port Washington Road. The officers detained the driver and, upon interviewing, determined the license plate had been attached to the vehicle by the driver's employer. At the completion of the investigation, the driver was released and the license plates confiscated to prevent additional traffic stops. No citations were issued.

2. On May 19, 2018 at 8:40pm, an officer on patrol located a vehicle in the 8300 block of North Port Washington Road which had been identified as fleeing the scene of a fight at Bayshore mall. The vehicle registration was not affiliated with the car and the registered owner had outstanding felony probation warrants. The officer conducted a traffic stop with the vehicle in the 8600 block of North Port Washington Road. As the officer approached the car, the driver accelerated away from the traffic stop. The officer, along with an officer from the Bayside police department pursued the vehicle west on Brown Deer Road for just over 1.5 miles before terminating the pursuit. The fleeing driver was operating at a dangerous speed and failed to stop for the red light at Range Line Road, creating a dangerous public situation. The office will conduct follow-up with the registered owner of the vehicle.
3. On May 20, 2018 at 3:08am, an officer conducted a traffic stop in the Riverpoint Shopping Center parking lot on a vehicle for outstanding arrest warrants. The driver's identity was confirmed and they were subsequently arrested for three outstanding arrest warrants from the Mequon police department. The driver was released after processing and satisfying the outstanding warrants.
4. On May 21, 2018 an officer met with a citizen who reported theft from the mail of personal documents and money. The citizen indicated that the money and personal information was being sent to a government agency in Chicago and was taken from the mail without permission. The money was in the form of a cashier's check, which showed cashed by the bank. The investigation remains open.
5. On May 24, 2018 at 1:44am, an officer conducted a traffic stop in the 8100 block of North Whitney Road for an equipment violation. The officer spoke with the driver who exhibited signs of impairment. The officer conducted field sobriety tests and based on their investigation, placed the driver under arrest for Operating While Impaired – 1st offense. The driver was processed at the station and will appear in municipal court.

Did you know?

Wisconsin has declared May 2018 as Trauma-Informed Care Awareness Month and May 22, 2018 as Trauma-Informed Care Day in Wisconsin. Trauma-informed Care (TIC) is not a therapy, intervention, or specific action. It is an approach to engaging people with histories of trauma that recognizes the presence of trauma symptoms and acknowledges the role that trauma has played in their lives. Trauma is extreme stress that overwhelms a person's ability to cope. It can be an event, a series of events, or set of circumstances that harms a person's physical or emotional well-being. The essence of TIC comes down to the question of not, 'What's wrong with you?' but, 'What happened to you?' This shift in perspective leads to answers that get at that root cause of issues.

There are four elements of a trauma-informed approach:

Realizing the prevalence of trauma - Many individuals experience trauma during their lifetime. Nationally, 61 percent men and 51 percent of women will experience at least one trauma in their lifetime.

Recognizing how trauma affects individuals - Research shows that trauma disrupts the central nervous system and overwhelms a person's ability to cope. It often results in feeling vulnerable, helpless, and afraid. It interferes with relationships and fundamental beliefs about oneself, others, and one's place in the world.

Responding by putting this knowledge into practice - This approach lessens the blame on people who have had adverse experiences in their lives and instead acknowledges it may not be their fault they are acting badly. It shows the person that there is an understanding that their past experiences may be affecting their present behavior. This promotes healing.

Resisting traumatization - TIC takes steps to minimize situations that could cause distress or mirror the person's traumatic experiences.

What is the North Shore Health Department working on?

Staff from the Health Department partnered with community police departments to help with helmet fitting and safety education at four bike rodeos last week. A bike rodeo is a fun obstacle course that is designed to teach bicycling safety skills to children as they get ready to start riding their bikes on the street. We participated in bike rodeos at Richards School and Cumberland School in Whitefish Bay, Stormonth School in Fox Point and the Glendale community bike rodeo at Parkway School. This year marked Glendale's first bike rodeo in many years and we had great participation. More importantly, everyone had fun!

Our long-time representative from Shorewood, Mary Jo Baisch, PhD, RN is retiring from the North Shore Board of Health. We thank Dr. Baisch for her many years of service to the North Shore Health Department. Dr. Baisch has provided leadership and guidance to the Health Department through its consolidation, seen the growth of the department from a Level I to Level III status, and supported the department's preparation for national accreditation.

As part of our efforts to strengthen and grow the public health workforce, the Health Department partners with Columbia St. Mary's Family Residency Program through the Medical College of Wisconsin to educate physician resident on local public health department functions. The Health Director met with a resident last week to discuss the North Shore Community Health Assessment, Public Health Essential Services, and how health systems and health departments work to prevent and control disease.
