Re: **Administrative Report for the Week Ending July 6, 2018**

ADMINISTRATION

1. The Fox Point Pool is up and running. Adult Swim from 7am to 8am Monday through Friday, toddler pool open to the public starting at 7am for the youngsters, **Masters Swim** Program is back for those interested in a sunrise workout and **Poolside Yoga** every Saturday morning! Check the pool website for Masters Swim and Yoga information!

2. **AFTER WORK FAMILY TIME! The daily rate after 5:00pm at the Fox Point Pool has been reduced to \$5 for an adult and \$5 for a child.** A notification to those signed up for pool notifications was sent out.
3. Staff facilitated Plan Commission/Building Board meeting.
4. Village Hall was closed on Independence Day.

DEPARTMENT OF PUBLIC WORKS

1. DPW Staff responded to the storm event on Sunday – there were a few downed trees/large limbs in the ROW that needed to be cleared.
2. Due to vacations and the holiday week, the contractor on Club Circle stopped work this week. However, they filled the water main so that they could begin testing it (pressure test and bacteria test).
3. One of the employees for the contractor on Goodrich hit utility lines on Tuesday and caused damage to the utility pole. We Energies responded and installed a new pole set and affixed the wires to the new pole.
4. Staff set out barricades for the 4th of July parade.
5. DPW staff continued installing the culverts on Longacre as part of the Stormonth repaving project. As staff got into the job, we determined that some of our buried pipe was completely rusted out and was replaced.
6. Staff continued to perform research in GIS related to sanitary sewer laterals and riser pipes.
7. Staff worked with property owners in an effort to obtain easements for the work occurring near their property.

POLICE DEPARTMENT

1. On Saturday, June 30th at 3:55 PM, Officers responded to the Porticos Apartments, (500 West Bradley Road) Building C, for a domestic disturbance. Several residents observed a male choking a female in the hallway. The male was later arrested and taken to the Milwaukee County Jail. Later in the week, criminal charges were sought at the Milwaukee County District Attorneys Office which were denied due to the victim not showing up. The male was issued two municipal citations for Disorderly Conduct and Battery.
2. On Sunday, July 1st, Officers responded to several locations around the village in regards to several trees and limbs that had been blown down due to the severe storm. Some of the trees or limbs were blocking the roadways. DPW was notified and was later cleared.
3. On Monday, July 2nd at 3:52 AM, Officers assisted the Bayside Police Department with the investigation of a death of an eight week old infant.
4. On Monday, July 2nd, Officers assisted the Wyoming State Police in looking for a subject who was previously arrested by them, but who was now calling them and making threats. The subject stated that he was at his parents house, which is at 560 East Fox Dale Court. Upon making contact with the parents, they stated that their son has not been there for at least 6 months and is now living in Wyoming. The Wyoming State Police were notified.
5. On Tuesday, July 3rd, Officers assisted the Whitefish Bay Police Department in looking for subjects who were breaking in to vehicles. The suspects were later arrested in Shorewood.
6. On Tuesday, July 3, at approximately 7:29 PM, an Officer attempted to stop a motorcycle for a registration violation on Port Washington Road. The motorcycle fled southbound on Port Washington Road at a high rate of speed and very recklessly so the officer terminated the pursuit.
7. On Tuesday, July 3, at 7:36 AM, Officers investigated a Hit and Run incident near Starbucks at 383 West Brown Deer Road. The vehicle was damaged approximately \$600.00. There was no video of the incident, nor any suspects were found.
8. On Wednesday, July 4th Officers assisted with the parade and following celebration at the Longacre Pavilion.
9. On Monday July 4th, at 12:48 AM, Officers found four unauthorized swimmers in the pool at the Town Club, 7950 North Santa Monica Boulevard. It was discovered that they were all employees of the Town Club and they left the location without incident.
